

RELEASE AND WAIVER OF LIABILITY

Please read carefully, as this is a legal document that affects your legal rights.

Volunteer refers to the individual volunteering with Dockley Ranch and the volunteer's parent or guardian if the volunteer is less than 18 years of age.

The Volunteer named above desires to work as a volunteer for Dockley Ranch, and engage in the activities related to being a volunteer. The Volunteer freely, voluntarily, and without duress executes this Release and Waiver of Liability under the following terms:

RELEASE AND WAIVER: The Volunteer releases and forever discharges and holds harmless Dockley Ranch and its successors and assigns from any and all liability or claims that the Volunteer (or the Volunteer's heirs or assigns) may have against Dockley Ranch with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's activities with Dockley Ranch. **THE VOLUNTEER UNDERSTANDS AND ACKNOWLEDGES THAT THE CLAIMS BEING RELEASED HEREIN INCLUDE, WITHOUT LIMITATION, CLAIMS, IF ANY, BASED ON OR IN ANYWAY RELATED TO THE NEGLIGENCE OR GROSS NEGLIGENCE OF DOCKLEY RANCH OR ITS OFFICERS, DIRECTOR, EMPLOYEES, OR AGENTS.**

INSURANCE: The Volunteer understands that Dockley Ranch does not assume any responsibility for or obligation to provide Volunteer with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of Volunteer's injury, illness, death or damage to Volunteer's property. Volunteer expressly waives any such claim for compensation or liability on the part of Dockley

Ranch beyond what may be offered freely by Dockley Ranch in the event of such injury or medical expenses that are incurred by Volunteer.

MEDICAL TREATMENT: Volunteer releases and forever discharges Dockley Ranch from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during Volunteer's tenure with Dockley Ranch.

ASSUMPTION OF RISK: The Volunteer understands that activities engaged while volunteering may be hazardous to the Volunteer. The Volunteer expressly and specifically assumes the risk of injury or harm in these activities.

Photographic Release: Volunteer grants and conveys to Dockley Ranch all right, title, and interest in any and all photographic images and video or audio recordings made by Dockley Ranch during the Volunteer's activities with Dockley Ranch, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Missouri Law: Volunteer expressly agrees that this Release and Waiver of Liability is intended to be as broad and inclusive as permitted by the laws of the State of Missouri and that it shall be governed and interpreted in accordance with the laws of the State of Missouri. Furthermore, Volunteer expressly agrees that if any one or more of the provisions contained in this Release and Waiver of Liability are held to be invalid, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Waiver and Release of Liability, which shall otherwise continue to be enforceable.

DOCKLEY RANCH releases and holds harmless the **VOLUNTEER** and assigns from any and all liability or claims that Dockley Ranch may have against the volunteer with respect to any bodily injury, personal injury, or property damage that may result from Volunteer's activities with Dockley Ranch.
